The Board wishes to inform the Shareholders and potential investors that the Group is expected to record a loss for the six months ended 30 June 2018 comparable to the loss of HK\$17,819,000 recorded for the six months ended 30 June 2017.

The information contained in this announcement is only based on the preliminary assessment by the Board with reference to the latest available consolidated management accounts of the Group, which have not been reviewed by the Company's auditor.

This announcement is made by Daido Group Limited (the "Company", together with its subsidiaries, the "Group") pursuant to Rule 13.09 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the "Listing Rules") and the Inside Information Provisions (as defined under the Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571, Laws of Hong Kong) (the "SFO").

Based on the information available for the time being, the board of directors (the "Board") of the Company wishes to inform the shareholders of the Company (the "Shareholders") and potential investors that the Group is expected to record a loss for the six months ended 30 June 2018 comparable to the loss of HK\$17,819,000 recorded for the six months ended 30 June 2017. The Board considers that the expected loss is primarily attributable to a significant drop in the storage volume of the cold storage business during the period of review.

The information contained in this announcement is only based on the preliminary assessment by the Board with reference to the latest available consolidated management accounts of the Group, which have not been reviewed by the Company's auditor. Details of the Group's financial performance will be disclosed in the interim results announcement of the Group which will be issued in August 2018.
