#### **WAIVER OF CONDITION TO PROPOSED CANCELLATION OF WARRANTS**

As disclosed in the Announcement, pursuant to the terms and conditions of the Termination Deed, the Termination should be subject to the conditions of (a) the passing of an ordinary resolution by the Shareholders at the EGM approving the Termination Deed and the transactions contemplated thereunder, if necessary; and (b) the approval of the Stock Exchange on the Termination having been obtained being fulfilled or waived by 5:00 p.m. on 30 September 2014.

The Board is pleased to announce that, on 22 August 2014, the Subscriber and the Company executed a letter of consent pursuant to which the Subscriber and the Company agreed to unconditionally waive the condition of obtaining approval from the Stock Exchange in relation to the Termination.

Save and except for this condition, another condition of passing of an ordinary resolution by the Shareholders at the EGM approving the Termination Deed and the transactions contemplated thereunder has not been satisfied as at the date of this announcement.
