Clarification Announcement

China Agrotech Holdings Limited (the “Company”) makes this announcement pursuant to Rule 13.09 of The Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited.

The board (the “**Board**”) of directors of the Company noted an article published in the ET Net on 6 October 2011 relating to the Company (the “**Article**”).

The Article stated that the Company had pledged the plantation site as security for a Renminbi loan in the Mainland China and the worst case would be the return of the plantation site. The Board would like to clarify that the above statement of the Article is not factually accurate and true. The Company did not pledge the said plantation site for any loan. The Company reserves all its right to take legal action in connection with the Article.

The Company noted today’s decrease in price and increase in trading volume of the shares of the Company and wish to state that except for the above clarification and the Company’s final results announcement dated 30 September 2011, we are not aware of any reason for such decrease in price and increase in trading volume.

We also confirm that there are no negotiations or agreements relating to intended acquisitions or realizations which are discloseable under rule 13.23, neither is the Board aware of any matter discloseable under the general obligation imposed by rule 13.09, which is or may be of a price-sensitive nature.
