If the Company does not receive the enclosed reply form or receive a response indicating the objection from you by 26 November 2020, you will be deemed to have consented to receive all future Corporate Communications by electronic means via the Website Version, and notification of the publication of the Corporate Communications on the Company’s website will be sent to you in the future.

You have the right at any time by reasonable prior notice in writing to the Company c/o the Hong Kong Share Registrar or by sending an email to the email address at dynamic-ecom@hk.tricorglobal.com to change the means of receipt of the Corporate Communications.
