### INTRODUCTION

The purpose of this circular is to provide you with information regarding (i) the proposed renewal of the general mandates to allot, issue and deal with Shares and to repurchase its own Shares and (ii) the proposed re-election of retiring Directors, and to seek your approval of the relevant ordinary resolutions relating to (i) and (ii) at the Annual General Meeting.

### **ISSUE MANDATE**

Ordinary resolutions will be proposed at the Annual General Meeting to grant to the Directors the Issue Mandate, and authorise the extension of the Issue Mandate, details of which are set out in ordinary resolutions numbered 5 and 7 respectively in the notice of Annual General Meeting.

Subject to the passing of the ordinary resolution granting the Issue Mandate to issue new Shares and on the basis that no further Shares are issued or repurchased prior the Annual General Meeting, the Company would be allowed under such Issue Mandate to issue a maximum of 216,571,879 Shares representing 20% of the issued share capital of the Company as at the date of passing of the ordinary resolution approving the Issue Mandate.

### **BUYBACK MANDATE**

On 26 June 2012, the Shareholders passed an ordinary resolution to give a general mandate to the Directors to exercise the powers of the Company to repurchase its own Shares. Such general mandate will lapse at the conclusion of the Annual General Meeting. It is therefore proposed to renew such general mandate at the Annual General Meeting.

An ordinary resolution will be proposed at the Annual General Meeting to grant to the Directors the Buyback Mandate, details of which are set out in ordinary resolution numbered 6 in the notice of Annual General Meeting. On the basis that no further Shares are issued or repurchased prior to the Annual General Meeting, the Shares which may be repurchased pursuant to the Buyback Mandate are limited to a maximum of 108,285,939 Shares representing 10% of the issued share capital of the Company as at the date of passing of the ordinary resolution approving the Buyback Mandate.

An explanatory statement as required under the Listing Rules, giving certain information regarding the Buyback Mandate, is set out in Appendix I to this circular.

### RE-ELECTION OF RETIRING DIRECTORS

As at the Latest Practicable Date, the executive Directors were Mr. WANG Yusuo, Mr. CHEUNG Yip Sang, Mr. ZHAO Jinfeng, Mr. YU Jianchao, Mr. Han Jishen, Mr. ZHAO Shengli and Mr. WANG Dongzhi; and the Non-executive Directors were Ms. ZHAO Baoju and Mr. JIN Yongsheng; and the Independent Non-executive Directors were Mr. WANG Guangtian, Ms. YIEN Yu Yu, Catherine, Mr. KONG Chung Kau, Mr. ZHANG Gang and Mr. LIM Haw Kuang.

In accordance with Article 99 of the Article of Association, Mr. ZHANG Gang, Mr. HAN Jishen and Mr. LIM Haw Kuang shall retire at the Annual General Meeting, while in accordance with Article 116 of the Articles of Association, Ms. ZHAO Baoju, Mr. JIN Yongsheng, Mr. CHEUNG Yip Sang, Mr. ZHAO Shengli and Mr. WANG Dongzhi shall retire by rotation at the Annual General Meeting. All the retiring Directors are eligible and offer themselves for re-election at the Annual General Meeting.

Details of the retiring Directors proposed to be re-elected at the Annual General Meeting are set out in Appendix II to this circular.

### ANNUAL GENERAL MEETING

The notice convening the Annual General Meeting is set out on pages 18 to 22 of this circular to consider the ordinary resolutions relating to the Issue Mandate, the Buyback Mandate, the extension of the Issue Mandate and the re-election of retiring Directors.

### ACTION TO BE TAKEN

A form of proxy for use at the Annual General Meeting is enclosed with this circular. Whether or not you propose to attend the Annual General Meeting, you are requested to complete the accompanying proxy form and return it to the Company's branch share registrar in Hong Kong, Computershare Hong Kong Investor Services Limited, at 17M Floor, Hopewell Centre, 183 Queen's Road East, Wanchai, Hong Kong and not less than 48 hours before the time appointed for holding the Annual General Meeting or any adjournment thereof. Completion and return of the proxy form will not preclude you from attending and voting at the Annual General Meeting or any adjourned meeting if you so desire.

### **VOTING BY WAY OF POLL**

Pursuant to Rule 13.39(4) of the Listing Rules, any vote of Shareholders at a general meeting must be taken by poll except where the chairman of the meeting, in good faith, decides to allow a resolution which relates purely to a procedural or administrative matter to be voted on by a show of hands. The Company will announce the results of the poll in the manner prescribed under Rule 13.39(5) of the Listing Rules.

### RECOMMENDATION

The Directors believe that the granting of the Issue Mandate and the Buyback Mandate, the extension of the Issue Mandate and the re-election of the retiring Directors are all in the best interests of the Company as well as the Shareholders as a whole. Accordingly, the Directors recommend that all the Shareholders should vote in favour of all the relevant ordinary resolutions to be proposed at the Annual General Meeting. So far as the Directors are aware, as at the Latest Practicable Date, no Shareholder is required to abstain from voting under the Listing Rules in respect of the resolutions to be proposed at the Annual General Meeting.

As at the date of this circular, the Board comprises 14 Directors, of whom Wang Yusuo, Cheung Yip Sang, Zhao Jinfeng, Yu Jianchao, Han Jishen, Zhao Shengli and Wang Dongzhi are Executive Directors; Zhao Baoju and Jin Yongsheng are Non-executive Directors; Wang Guangtian, Yien Yu Yu, Catherine, Kong Chung Kau, Zhang Gang and Lim Haw Huang are Independent Non-executive Directors.

This appendix serves as an explanatory statement, as required by the Listing Rules, to provide you with requisite information for your consideration of the Buyback Mandate.

### 1. EXERCISE OF THE BUYBACK MANDATE

Exercise in full of the Buyback Mandate, on the basis of 1,082,859,397 Shares in issue at the Latest Practicable Date could result in up to 108,285,939 Shares being repurchased by the Company during the period up to (i) the conclusion of the next annual general meeting of the Company; (ii) the expiration of the period within which the next annual general meeting of the Company is required by the Articles of Association or any applicable laws to be held; or (iii) the revocation, variation or renewal of the Buyback Mandate by ordinary resolution of the Shareholders in general meeting, whichever occurs first.

### 2. REASONS FOR REPURCHASES

Repurchases of Shares will only be made when the Directors believe that such a repurchase will benefit the Company and the Shareholders. Such repurchases may, depending on market conditions and funding arrangements at the time, lead to an enhancement of the net asset value of the Company and/or its earnings per Share.

## 3. FUNDING OF REPURCHASES

In repurchasing Shares, the Company may only apply funds legally available for such purpose in accordance with its memorandum and articles of association and the applicable laws of the Cayman Islands. The law of the Cayman Islands provides that the amount to be repaid in connection with a Share repurchase may be paid from the profits of the Company and/or the proceeds of a new issue of Shares made for the purpose of the repurchase or out of capital, if the Company can, immediately following such payment, pay its debts as they fall due in the ordinary course of business. The Company may not purchase securities on the Stock Exchange for a consideration other than cash or for settlement otherwise than in accordance with the trading rules of the Stock Exchange from time to time.

### 4. GENERAL

There might be a material adverse impact on the working capital or gearing position of the Company (as compared with the position disclosed in the audited accounts contained in the 2012 annual report of the Company) in the event that the Buyback Mandate is exercised in full. However, the Directors do not propose to exercise the Buyback Mandate to such extent as would, in the circumstances, have a material adverse effect on the working capital requirements of the Company or on its gearing position which in the opinion of the Directors are from time to time appropriate for the Company.

The Directors have undertaken to the Stock Exchange that, so far as the same may be applicable, they will exercise the Buyback Mandate in accordance with the Listing Rules, the memorandum and articles of association of the Company and the applicable laws of the Cayman Islands.

None of the Directors and, to the best of their knowledge, having made all reasonable enquiries, none of their respective associates (as defined in the Listing Rules), have any present intention, if the Buyback Mandate is exercised, to sell Shares to the Company.

No connected person (as defined in the Listing Rules) of the Company has notified the Company that he has a present intention to sell Shares to the Company or has undertaken not to do so.

If as a result of a repurchase of Shares, a Shareholder's proportionate interest in the voting rights of the Company increases, such increase will be treated as an acquisition for the purpose of the Takeovers Code. As a result, a Shareholder, or a group of Shareholders acting in concert, depending on the level of increase in the Shareholder's interests, could obtain or consolidate control of the Company and become(s) obliged to make a mandatory offer in accordance with Rule 26 of the Takeovers Code.

As at the Latest Practicable Date, Mr. WANG Yusuo and Ms. ZHAO Baoju (the spouse of Mr. WANG Yusuo), directors of the Company, together with EGII (a company which is beneficially owned as to 50% by Mr. WANG Yusuo and 50% by Ms. ZHAO Baoju) were beneficially interested in an aggregate of 326,691,000 Shares, representing approximately 30.17% of the issued share capital of the Company. Based on such shareholdings and in the event that the Directors exercised in full the power to repurchase Shares under the Buyback Mandate, the shareholdings of Mr. WANG Yusuo and Ms. ZHAO Baoju together with EGII would be increased to approximately 33.52% of the issued share capital of the Company. Then, Mr. WANG Yusuo and Ms. ZHAO Baoju together with EGII could be required under Rule 26 of the Takeovers Code to make a mandatory offer in respect of all the issued shares of the Company by reason of such increase.

Save as aforesaid, the Directors are not aware of any consequences which may arise under the Takeovers Code as a consequence of any purchases made under the Buyback Mandate. The Directors will use their best endeavours to ensure that the Buyback Mandate will not be exercised to the extent that the number of Shares held by the public would be reduced to less than 25% of the issued share capital of the Company. The Directors have no intention to exercise the Buyback Mandate which may result in possible mandatory offer being made under the Takeovers Code.

## 5. SHARE PURCHASED BY THE COMPANY

The Company had not repurchased any of its Shares (whether on the Stock Exchange or otherwise) in the six months preceding the Latest Practicable Date.

The following are the particulars of the retiring Directors proposed to be re-elected at the Annual General Meeting:

## Mr. ZHANG Gang

Mr. ZHANG Gang, aged 62, is an Independent Non-executive Director of the Company. He is a Senior Engineer who has extensive experience in quality, safety management and construction of energy-related projects. From August 1999 to April 2001, he worked in the State Administration of Quality and Technical Supervision, and served as a Deputy Director and Director subsequently in Boiler and Pressure Vessel Safety Supervision Bureau in the PRC. Mr. Zhang was then appointed as the Director in Special Equipment Safety Supervision Bureau of General Administration of Quality Supervision, Inspection and Quarantine ("AQSIQ") of the PRC. As at the Latest Practicable Date, Mr. Zhang does not have any interests in the shares of the Company within the meanings of Part XV of the SFO, and neither is he connected with any directors, senior management, substantial shareholders or controlling shareholders of the Company.

The remunerations of Independent Non-executive Directors are determined by reference to his responsibilities and duties with the Company, the remuneration benchmark in the industry and the prevailing market conditions. Pursuant to the terms of the service agreement, Ms. Zhang is entitled to an annual remuneration of RMB200,000 for the year ended 31 December 2012 in a pro-rata basis.

Save as disclosed above, Mr. Zhang has confirmed that there are no other matters that need to be brought to the attention of the Shareholders in connection with his re-election and there are no information that should be disclosed pursuant to rules 13.51(2)(h) to (v) of the Listing Rules.

## Mr. HAN Jishen

Mr. HAN Jishen, aged 48, is an Executive Director and the President of the Company responsible for assisting the Chief Executive Officer in business expansion. He joined the Group in 1993 and was graduated from Baoding Staff University in 1990 and obtained an executive master's degree in business administration from the Nanyang Technological University in Singapore in 2007. He has over 20 years of experience in the gas fuel industry in the PRC. Mr. Han worked at the senior managerial level for over 10 years at the subsidiary level of the Company.

Save as disclosed above, Mr. Han had not held any other directorships or major appointments in any other listed public companies in the last three years.

Mr. Han has entered into a service agreement with the Company for the period of one year commencing from 26 March 2013. The contract will be automatically renewed every year upon expiry until terminated by either party by giving the other party a written notice not less than six months in advance. The appointment is subject to retirement or retirement by rotation and re-election at the annual general meeting in accordance with the articles of association of the Company.

As at the Latest Practicable Date, Mr. Han does not have any other interests in the shares of the Company within the meaning of Part XV of the SFO, and neither is he connected with any directors, senior management, substantial shareholders or controlling shareholders of the Company.

The remuneration of Executive Directors are determined by reference to his responsibility and duties with the Company, his performance, the Company's performance and profitability, as well as the remuneration benchmark in the industry and the prevailing market conditions. Pursuant to terms of the service agreement, Mr. Han is entitled to an annual remuneration of RMB920,000.

Save as disclosed above, Mr. Han has confirmed that there are no other matters that need to be brought to the attention of the Shareholders in connection with his re-election and there are no information that should be disclosed pursuant to rules 13.51(2)(h) to (v) of the Listing Rules.

### Mr. LIM Haw Kuang

Mr. LIM Haw Kuang, aged 59, is an independent Non-executive Director of the Company. He has extensive experience in the oil and gas business. Mr. Lim joined Shell in Malaysia in 1978 and had served in various capacities in IT, Finance, Natural Gas, Exploration and Production, Oil Products, etc in different Shell operations globally. Mr. Lim was appointed as the Executive Chairman of Shell Companies in China in September 2005, a position he held until 1 January 2013. He retired from Shell on 1 March 2013. Mr. Lim has been appointed as an independent board director for Sime Darby Group, a Malaysian conglomerate, since September 2010, and is concurrently Chairman of the Boards of Sime Darby Energy & Utilities. With effect from 4 March 2013, Mr. Lim has also been appointed as a Non-executive Director of BG Group, a global gas major based in the UK. Mr. Lim graduated from Imperial College, University of London in 1978. In 1986, he graduated from International Management Institute, Geneva with a MBA in International Management.

The contract will be automatically renewed for 3 years upon expiry until terminated by either party by giving the other party a written notice not less than six months in advance. The appointment is subject to retirement or retirement by rotation and re-election at the annual general meeting in accordance with the articles of association of the Company.

As at the Latest Practicable Date, Mr. Lim does not have any interests in the shares of the Company within the meaning of Part XV of the SFO, and neither is he connected with any directors, senior management, substantial shareholders or controlling shareholders of the Company.

The remuneration of Independent Non-executive Directors are determined by reference to his responsibility and duties with the Company, the remuneration benchmark in the industry and the prevailing market conditions. Pursuant to terms of the service agreement, Mr. Lim is entitled to an annual remuneration of RMB200,000.

Save as disclosed above, Mr. Lim has confirmed that there are no other matters that need to be brought to the attention of the Shareholders in connection with his re-election and there are no information that should be disclosed pursuant to rules 13.51(2)(h) to (v) of the Listing Rules.

## Ms. ZHAO Baoju

**Ms. ZHAO Baoju,** aged 47, is a Cofounder and a Non-executive Director of the Company. She has over 20 years of experience in investing in gas fuel projects in the PRC. She graduated from the Hebei Medical College Professional Nursing School in 1987 and the Chinese Language Faculty of Capital Normal University in 1998.

Ms. Zhao holds directorship in one principal subsidiary of the Group. Save as disclosed above, Ms. Zhao has not held any other positions with any members of the Group and in the last three years, she had not held any other directorships or major appointments in any listed public companies.

Ms. Zhao was re-appointed by the Company for a term of three years commencing 1 March 2010, and the appointment shall continue thereafter unless and until terminated by either party giving to the other not less than six months' prior written notice. The appointment is subject to retirement by rotation and re-election at the annual general meeting in accordance with the Articles of Association of the Company.

Ms. Zhao is a Director and a controlling shareholder of EGII, which is a controlling shareholder of the Company. She is the spouse of Mr. Wang Yusuo and the sister of Mr. Zhao Jinfeng, the executive Director of the Company. Save as disclosed above, Ms. Zhao does not have any relationship with any other Directors, senior management, substantial Shareholders or controlling Shareholders of the Company.

As at the Latest Practicable Date, save for the interest of spouse in 596,000 Shares and, together with spouse, 100% interest in EGII which holds 326,095,000 Shares, Ms. Zhao did not have any other interests in the Shares within the meaning of Part XV of the SFO.
