PROFIT WARNING

This announcement is made by the Company pursuant to Rule 13.09 of the Listing Rules and the Inside Information Provisions under Part XIVA of the SFO.

The Board wishes to inform the shareholders of the Company and potential investors that, based on the preliminary review of the Group's currently available unaudited consolidated management accounts for the 11 months ended 30 November 2013 and the information available for the time being, the Group is expected to record a significant decrease in the consolidated profit attributable to the ordinary equity holders of the Company for the year ended 31 December 2013 as compared to that for the year ended 31 December 2012.

Shareholders of the Company and potential investors are advised to exercise caution when dealing in the shares of the Company.

The board of directors (the “**Board**”) of Evergreen International Holdings Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) makes this announcement pursuant to Rule 13.09 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”) and the Inside Information Provisions under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong) (the “**SFO**”).

The Board wishes to inform the shareholders of the Company and potential investors that, based on the preliminary review of the Group's currently available unaudited consolidated management accounts for the 11 months ended 30 November 2013 and the information available for the time being, the Group is expected to record a significant decrease in the consolidated profit attributable to the ordinary equity holders of the Company for the year ended 31 December 2013 as compared to that for the year ended 31 December 2012. Based on the information currently available to the Board, the expected decrease in the consolidated profit attributable to the ordinary equity holders of the Company is mainly attributable to (1) the decrease in revenue as a result of worsening market condition and sluggish retail environment; (2) the decrease in gross profit margin because of keen competition in the retail sector; (3) the increase in selling and distribution expenses

including but not limited to the increase in operating lease rental expenses (including contingent rents charged by department stores); and (4) the decrease in bank interest income as a result of the decrease in net cash and cash equivalents.

The Company is still in the process of finalizing the annual results of the Group for year ended 31 December 2013. The annual results announcement of the Company for the year ended 31 December 2013 is expected to be released in March 2014. The information contained in this announcement is only a preliminary assessment made by the management of the Company based on the unaudited consolidated management accounts of the Group up to 30 November 2013, which is not based on any figures or information confirmed or reviewed by the Company's auditors.

Shareholders of the Company and potential investors are advised to exercise caution when dealing in the shares of the Company.
