Reference is made to the Company's announcements dated 14 June 2013, 19 August 2013, 12 September 2013, 2 May 2014 and 22 May 2014 respectively (the "Announcements") in relation to the proposed spin-off and separate listing of Colour Life on the Main Board of The Stock Exchange of Hong Kong Limited (the "Stock Exchange"). Capitalised terms in this notification letter have the same meanings given to them in the Announcements unless otherwise specified.

Please be advised that Colour Life has published the Prospectus on 17 June 2014. In connection with the Preferential Offering, a BLUE application form has been dispatched on 17 June 2014 to each Qualifying Fantasia Shareholder who is entitled to apply for Reserved Shares on an assured basis under the Preferential Offering. Qualifying Fantasia Shareholders who hold less than 230 Fantasia Shares on the Record Date will not have an Assured Entitlement (as defined in the Prospectus) to the Reserved Shares, but they will still be entitled to participate in the Preferential Offering by applying for excess Reserved Shares. The Prospectus is available for viewing and downloading from the HKExnews' website at [www.hkexnews.hk](http://www.hkexnews.hk) and from Colour Life's website at [www.colourlife.hk](http://www.colourlife.hk) from 17 June 2014. For Shareholder who has elected to receive Corporate Communications(1) in printed form, the printed version(s) of the Prospectus is/are enclosed herewith.

**— 就建議分拆彩生活服務集團有限公司(「彩生活」)獨立上市刊發招股章程(「招股章程」)的通知**
