POLL RESULTS

OF THE ANNUAL GENERAL MEETING

HELD ON 19 APRIL 2013

At the annual general meeting of unitholders (“**Unitholders**”) of Fortune Real Estate Investment Trust (“**Fortune REIT**”) held on 19 April 2013 (“**AGM**”), all the resolutions as set out in the notice of AGM of Fortune REIT dated 15 March 2013 were proposed and decided on by way of poll as ordinary resolutions (the “**Ordinary Resolutions**”) including, (a) the resolution to receive and adopt the Trustee’s Report, Statement by the Manager, Audited Financial Statements of Fortune REIT for the year ended 31 December 2012 and the Auditor’s Report thereon, (b) the resolution to re-appoint Deloitte & Touche LLP and Deloitte Touche Tohmatsu as auditors of Fortune REIT (“**Auditors**”) and authorise ARA Asset Management (Fortune) Limited, as manager of Fortune REIT (the “**Manager**”) to fix the Auditors’ remuneration, and (c) the resolution to authorise the Manager to issue units in Fortune REIT (“**Units**”) and to make or grant convertible instruments.

As at the date of the AGM, the number of Units in issue was 1,702,420,481, which was the total number of Units entitling the Unitholders to attend and vote for or against all the resolutions proposed at the AGM. There were no restrictions on any Unitholders relating to the exercise of their votes on any of the proposed resolutions at the AGM.

The poll at the AGM was scrutinised by the auditor of Fortune REIT, Deloitte & Touche LLP. Each of the proposed Ordinary Resolutions was duly passed as an ordinary resolution based on the voting details set out below.
