Focus Eagle, an indirect wholly-owned subsidiary of Cheung Kong (Holdings) Limited ("CKH"), holds 413,074,684 units in Fortune Real Estate Investment Trust ("Fortune REIT"). As such, Cavell Limited ceased to have any deemed interest in Fortune REIT.

(ii) Change of the holding company of CKH

On 18 March 2015, CK Hutchison Holdings Limited ("CK Hutchison"), a company incorporated in the Cayman Islands with limited liability and listed on the Stock Exchange of Hong Kong Limited, has become the new holding company of CKH. Accordingly, CKH and its subsidiaries have become subsidiaries of CK Hutchison as referred to in the Announcement of CK Hutchison dated 18 March 2015.


