POLL RESULTS OF THE ANNUAL GENERAL MEETING HELD ON 27 MAY 2022

The Manager wishes to announce that at the AGM held today, 27 May 2022, the resolution was duly passed as Ordinary Resolution by way of poll.

Reference is made to the circular dated 22 April 2022 (the "**Circular**") issued by ARA Asset Management (Fortune) Limited, as the Manager of Fortune REIT, to the Unitholders. Unless the context requires otherwise, terms used in this announcement shall have the same meaning as those defined in the Circular.

POLL RESULTS OF THE ANNUAL GENERAL MEETING HELD ON 27 MAY 2022

At the AGM, the resolution to approve the grant of the Unit Buy-back Mandate as set out in the AGM Notice dated 22 April 2022 (the "**AGM Resolution**") was proposed and decided on by way of poll as Ordinary Resolution. All Directors of the Manager attended the AGM in person or by electronic means.

As at the date of the AGM, the number of Units in issue was 1,977,947,795, which was the total number of Units entitling the Unitholders to attend and vote for or against the resolution proposed at the AGM. To the best of the Manager's knowledge, information and belief, after having made reasonable enquiries, no Unitholder is required to abstain from voting at the AGM in respect of the AGM Resolution.

The poll at the AGM was scrutinised by the unit registrar of Fortune REIT, Computershare Hong Kong Investor Services Limited. As more than 50% of the votes were cast in favour of the AGM Resolution, the AGM Resolution was duly passed as an Ordinary Resolution based on the voting details set out below.
