No Shareholders is required to abstain from voting at the AGM in respect of the above ordinary resolutions and therefore all Shareholders holding a total of 1,199,746,993 Shares were entitled to attend and vote on the ordinary resolutions proposed at the AGM. There were no Shares entitling the Shareholders to attend and vote only against the resolutions at the AGM. None of the Shareholders has stated their intention in the Circular to vote against the resolutions at the AGM.
