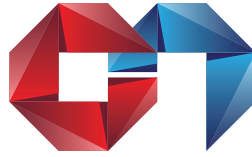

This announcement is made by the Company pursuant to Rule 17.10 of the GEM Listing Rules and the Inside Information Provisions under Part XIVA of the SFO.

The Board wishes to inform the Shareholders and potential investors that, based on the unaudited consolidated management accounts of the Group and the information currently available, the Group expects to record a profit attributable to owners of the Company for the three months ended 31 March 2021 within a range of HK\$30.00 million to HK\$36.00 million as compared to a loss of HK\$17.83 million for the three months ended 31 March 2020.

**Shareholders and potential investors are advised to exercise caution when dealing in the shares of the Company.**

This announcement is made by Global Mastermind Holdings Limited (the “**Company**”, together with its subsidiaries as the “**Group**”) pursuant to Rule 17.10 of the Rules Governing the Listing of Securities on GEM of The Stock Exchange of Hong Kong Limited (the “**GEM Listing Rules**”) and the Inside Information Provisions (as defined under the GEM Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong) (the “**SFO**”).

The board (the “**Board**”) of directors (the “**Directors**”) of the Company wishes to inform the shareholders (the “**Shareholders**”) of the Company and potential investors that, based on the unaudited consolidated management accounts of the Group and the information currently available, the Group expects to record a profit attributable to owners of the Company for the three months ended 31 March 2021 within a range of HK\$30.00 million to HK\$36.00 million, as compared to a loss of HK\$17.83 million for the three months ended 31 March 2020.

The turnaround from loss to profit was due to the recognition of a HK\$38.12 million net unrealised gain on securities investment, whereas a HK\$11.46 million net unrealised loss on securities investment was reported in the corresponding period last year.

The Company is still finalising the unaudited first quarterly results of the Group for the three months ended 31 March 2021. The information contained in this announcement is only a preliminary assessment by the Board based on the unaudited consolidated management accounts of the Group and the information currently available, which have not been finalised nor reviewed by the Audit Committee of the Board and may be subject to changes and adjustments. Shareholders and potential investors are advised to read carefully the first quarterly results announcement of the Company for the three months ended 31 March 2021, which is scheduled to be published on 10 May 2021.
