**POLL RESULTS OF THE EXTRAORDINARY GENERAL MEETING
HELD ON 21 MARCH 2018**

Reference is made to the announcement of Glorious Property Holdings Limited (the “**Company**”) dated 14 February 2018, the notice of the extraordinary general meeting (the “**EGM Notice**”) and the circular (the “**Circular**”) of the Company both dated 28 February 2018 in relation to the Revised Annual Caps under the New Construction Services Agreement. Capitalised terms used herein shall have the same meanings as ascribed thereto in the Circular unless stated otherwise.

POLL RESULTS OF THE EGM

The board of directors of the Company (the “**Board**”) announces that at the EGM of the Company held on 21 March 2018, the ordinary resolution as set out in the EGM Notice was not passed by the Independent Shareholders by way of poll. The poll results are as follows:

As more than 50% of the vote was cast against the above ordinary resolution at the EGM, the above ordinary resolution was not passed as an ordinary resolution of the Company.

As at the date of the EGM, the total number of Shares in issue of the Company was 7,792,645,623 Shares. As stated in the Circular, Mr. Zhang Zhi Rong and his associates (including Best Era, Island Century Limited, Market Victor Limited, Novel Ventures Limited and Well Advantage Limited, all of which are directly or indirectly wholly-owned by Mr. Zhang Zhi Rong), being connected persons of the Company and having material interests in the Construction Services Agreements (which are different from those of the Independent Shareholders), held 5,311,022,436 Shares, representing approximately 68.15% of the total issued share capital of the Company as at the date of the EGM, abstained from voting in respect of the above ordinary resolution. The total number of Shares entitling the Shareholders to attend and vote (in person, by proxy or by corporate representative) for or against the above ordinary resolution at the EGM was 2,481,623,187 Shares, representing approximately 31.85% of the total issued share capital of the Company as at the date of the EGM. Save as disclosed above, no Shareholder was required to abstain from voting in favour or only entitled to vote against the above ordinary resolution at the EGM.

The Company's Hong Kong share registrar, Computershare Hong Kong Investor Services Limited, acted as the scrutineer at the EGM for the purpose of vote-taking.
