Ms. Li has also been appointed as the company secretary of the subsidiaries of the Company and as the authorised representative of the Company under the Companies Ordinance and the Listing Rules. Ms. Li is an associate member of the Hong Kong Institute of Certified Public Accountants, associate member of the Association of International Accountants, associate member of the Hong Kong Institute of Chartered Secretaries and associate member of the Institute of Chartered Secretaries and Administrators. Ms. Li has worked with various certified public accountants firms for over 10 years. She was the financial controller and company secretary of a company listed on the Main Board of The Hong Kong Stock Exchange prior to joining the Company.
