UPDATED INFORMATION IN RESPECT OF THE SUMMONS
ISSUED IN CHINA AGAINST
TWO OF THE SUBSIDIARIES OF THE COMPANY
AND TWO OTHER DEFENDANTS
APPEAL BY HKZX DISMISSED**

This announcement is made pursuant to Rule 13.09 of the Listing Rules and Part XIVA of the Securities and Futures Ordinance (Chapter 571, Laws of Hong Kong).

Reference is made to the announcement of the Company dated 9 August, 2013 in connection with allegation II of the Company-related allegations appeared on the local newspaper and some PRC financial Websites on 10 June 2013 and 11 June 2013 in relation to the allegations that the Group had understated its interest in the Shenzhen Land.

Reference is also made to the announcements of the Company respectively dated 3 January, 2014, 27 February, 2014, 28 March, 2014 and 12th May, 2014 (hereinafter collectively referred to as “the Announcements”) in connection with the Summons issued and filed with the Longgang Court against two of the subsidiaries of the Company and two other defendants and the civil judgment of the Summons delivered on 19 March, 2014 by the Longgang Court (“the Judgment”) in which all the claims by HKZX in the Summons were dismissed and the Appeal lodged by HKZX with Shenzhen City Intermediate People’s Court against the Judgment. Unless the context herein required otherwise, capitalized terms used in this announcement shall have the same meanings as those defined in the Announcements.

The Board announces that the Board has on 4th September, 2014 (after business hours) become aware that by the civil judgment dated 2nd September, 2014 made by the intermediate People's Court of Shenzhen City, Guangdong Province (the "Civil Judgment"), the Appeal lodged by HKZX was dismissed and the Judgment was upheld. It was further stated that the Civil Judgment was a final one.

The Company will keep the Shareholders and potential investors informed of any further material development in connection with this matter and/or the Shenzhen Land and shall make further announcement to clarify all matter arisen therefrom in due course.
