1. On 16 November 2016, the Company granted 96,989,645 share options (the “Share Options”) to individuals (the “Grantees”), under the share option scheme adopted by the Company on 21 June 2016. The Share Options shall entitle the Grantees to subscribe for a total of 96,989,645 new ordinary shares of HK\$0.1 each in the share capital of the Company during the period from 16 November 2016 to 15 November 2019.

2. Reference is made to the announcements (the “Announcements”) dated 21 November 2016 and 30 November 2016 of the Company in relation to the subscription of shares under general mandate. On 21 November 2016, the Company entered into the subscription agreements with two subscribers respectively pursuant to which the Company has conditionally agreed to allot and issue, and each of the two subscribers has conditionally agreed to subscribe for, an aggregate of 62,952,645 subscription shares at the subscription price of HK\$0.2154 per subscription share. The subscription shares had been allotted and issued on 30 November 2016 under the general mandate in pursuant to the resolution passed on the annual general meeting on 21 June 2016.
