On 12 January 2017, the Company entered into the subscription agreements with two subscribers respectively pursuant to which the Company has conditionally agreed to allot and issue, and each of the two subscribers has conditionally agreed to subscribe for, an aggregate of 90,468,877 subscription shares at the subscription price of HK\$0.27 per subscription share. The subscription shares had been successfully allotted and issued to the subscribers on 19 January 2017. For details, please refer to the announcements dated 13 January 2017 and 19 January 2017 of the Company in relation to the subscription of shares and issue of the remuneration shares under general mandate (the “Announcements”).
 2. On 12 January 2017, the Company entered into the fees settlement agreement with the legal adviser of the Company, Simon Ho & Co., Solicitors (“Legal Adviser”), pursuant to which the Company has agreed with the Legal Adviser to settle the outstanding professional fees of HK\$3,500,000 by the issuance and allotment of 12,962,963 remuneration shares to Mr. Wong Vai Nang at an issue price of approximately HK\$0.27 per remuneration share. The remuneration shares had been successfully allotted and issued to Mr. Wong Vai Nang on 19 January 2017. For details, please refer to the Announcements.
