1. The Company has issued convertible bonds in an aggregate principal amount of HK\$137,000,000 on 28 April 2017. Details were set out in the announcements of the Company dated 24 February 2017 and 24 March 2017 and the circular of the Company dated 30 March 2017 in relation to major and connected transaction in relation to acquisition of entire share capital of the target company. As a result of the open offer, the conversion price of the convertible bonds has been adjusted from HK\$0.226 per conversion share to HK\$0.222 per conversion share. On 14 August 2018, the Company has partially redeemed the convertible bonds for the principal amount of HK\$24,680,000 in accordance with the terms of the convertible bonds. The convertible bonds were expired during the month.
