The Board is pleased to announce that the name of the Company has been changed from “Smart Union Group (Holdings) Limited 合俊集團(控股)有限公司” to “Green International Holdings Limited 格林國際控股有限公司” with effect from 24 April, 2012. The Certificate of Registration of Change of Corporate Name of Non-Hong Kong Company was issued by the Registrar of Companies in Hong Kong on 16 May, 2012 certifying that the new name of the Company has been registered in Hong Kong under Part XI of the Companies Ordinance (Chapter 32 of the Laws of Hong Kong).

The stock short name of the Company for trading in the Shares on the Stock Exchange will be changed from “SMART UNION GP” to “GREEN INTL HLDG” in English and from “合俊集團” to “格林國際控股” in Chinese with effect from 25 May, 2012. The stock code of the Company remains unchanged.

Reference is made to the announcement (the “**Announcement**”) and the circular (the “**Circular**”) of the Company dated 13 March 2012 and 20 March 2012 respectively in relation to the proposed Change of Company Name. Unless otherwise defined herein, capitalised terms used in this announcement shall have the same meanings as those defined in the Announcement and the Circular.

**CHANGE OF COMPANY NAME**

The Board is pleased to announce that subsequent to the passing of a special resolution regarding the Change of Company Name by the Shareholders by way of poll at the EGM held on 12 April 2012, the Certificate of Incorporation on Change of Name was issued by the Registrar of Companies in the Cayman Islands on 24 April 2012. The Change of Company Name from “Smart Union Group (Holdings) Limited 合俊集團(控股)有限公司” to “Green

International Holdings Limited 格林國際控股有限公司” has become effective on 24 April, 2012. The Certificate of Registration of Change of Corporate Name of Non-Hong Kong Company was issued by the Registrar of Companies in Hong Kong on 16 May, 2012 certifying that the new name of the Company has been registered in Hong Kong under Part XI of the Companies Ordinance (Chapter 32 of the Laws of Hong Kong).

Accordingly, the Company has also adopted a new logo which will be printed on all corporate documents of the Company.

### **EFFECT OF CHANGE OF COMPANY NAME**

The Change of Company Name will not affect any rights of the Shareholders or the Company’s daily business operation and its financial position. All existing share certificates in issue bearing the existing name of the Company will continue to be effective as documents of title to and be valid for trading, settlement, registration and delivery purposes.

There will not be any arrangement for the exchange of the existing share certificates of the Company for new share certificates bearing the new name and logo of the Company. New share certificates will be issued under the new name of the Company.

### **CHANGE OF STOCK SHORT NAME**

Following the change of Company’s name becoming effective, the stock short name of the Company for trading in the Shares on the Stock Exchange will be changed from “SMART UNION GP” to “GREEN INTL HLDG” in English and from “合俊集團” to “格林國際控股” in Chinese with effect from 25 May, 2012 at 9:00 a.m.. The stock code of the Company remains unchanged.
