References are made to the notice (the “**AGM Notice**”) of the annual general meeting (the “**AGM**”) and the circular (the “**AGM Circular**”) of Green International Holdings Limited (the “**Company**”) both dated 28 April 2022. Capitalised terms used in this announcement shall have the same meanings as those defined in the AGM Circular unless the context otherwise requires.

POLL RESULTS OF THE AGM

The AGM was held on 9 June 2022. Tricor Investor Services Limited, the Company’s Hong Kong branch share registrar and transfer office, was appointed as the scrutineer for the vote-taking at the AGM.

All the proposed resolutions set out in the AGM Notice were taken by poll by the shareholders of the Company (the “**Shareholders**”) at the AGM. The poll results of the AGM are as follows:

There were no Shares entitling the Shareholders to attend and abstain from voting in favour of any resolution at the AGM pursuant to Rule 13.40 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited. There were no Shareholders who are required under the Listing Rules to abstain from voting at the AGM.

The independent non-executive director Mr. David Tsoi attended the AGM in person. The executive directors Mr. Liu Dong and Mr. Yu Xiangjin; the non-executive directors Mr. Chen Hanhong and Mr. Yu Zhoujie (Chairman); and the independent non-executive directors Mr. Wu Hong and Mr. Wang Chunlin attended the AGM by electronic means.
