ANNOUNCEMENT

Reference is made to the announcement (the “**December Announcement**”) of Greentown China Holdings Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) dated 29 December 2011 in relation, among other things, the disposal of a then wholly-owned subsidiary of the Company to a third party (the “**Transaction**”). Unless otherwise stated, terms defined in the December Announcement shall have the same meaning when used herein.

As disclosed in the Company’s announcement dated 31 May 2012, Fosun International Limited (“**Fosun**”, together with its subsidiaries, the “**Fosun Group**”) made an announcement on 30 May 2012 in relation to, among other things, the filing of a civil suit by Zhejiang Fosun Commerce Development Limited to Shanghai No. 1 Intermediate People’s Court (the “**Court**”), pursuant to which the Fosun Group had initiated a civil action against the relevant parties to protect its pre-emptive rights in, among other things, the Transaction (the “**Court Action**”).

On 4 June 2012, the Group was served with a 傳票 (document of summons*) issued by the Court in relation to the Court Action, pursuant to which Greentown Jiahe, among others, is named as a defendant. Having discussed with the PRC legal advisers, the Company believes that the Transaction did not constitute a breach of the pre-emptive rights as alleged by the Fosun Group in the 傳票 (document of summons*). The Company considers that the Court Action does not have any material adverse effect on the operation or financial position of the Group.
