This announcement is made by Unity Investments Holdings Limited (the “**Company**” and together with its subsidiaries, the “**Group**”) pursuant to Inside Information Provisions (as defined in the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”)) under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong) (the “**SFO**”) and Rule 13.09(2)(a) of the Listing Rules.

The board of directors (the “**Board**”) of the Company wishes to inform the shareholders of the Company (the “**Shareholders**”) and potential investors that, based on the preliminary assessment of the Group's unaudited management accounts for the year ended 31 December 2018 (the “**Current Year**”) and information currently available to the Board, the Group is expected that the unaudited consolidated net loss for the Current Year decreased significantly as compared to the audited consolidated net loss for the year ended 31 December 2017 (“**Last Year**”) as set out in the 2017 annual report of the Company. Such change is mainly attributable to the decrease in loss on listed investments for the Current Year as compared to that for Last Year.

The information contained in this announcement is only based on the preliminary assessment made by the Board with reference to the unaudited management accounts of the Group for the Current Year and information currently available and such information has not been audited or reviewed by the Company's auditor. Shareholders and potential investors are advised to read carefully the annual results announcement of the Company for the Current Year which is expected to be issued in March 2019.
