(1) A maximum of 520,000,000 Conversion Shares (upon full conversion of possibly be issued Convertible Notes) may possibly be issued in relation to a memorandum of understanding signed on 31 January 2010 and agreements signed on 22 October 2010. Conversion Price of the possible issue of Shares is HK\$0.6.

(2) The proposed extension of the maturity date of the outstanding convertible note for principal amount of HK\$533,700,000 for a further term of 5 years as described in the circular dated 20 December 2013 to shareholders has been approved by independent shareholders at an extraordinary general meeting held on 17 January 2014. The convertible note with an outstanding principal amount of HK\$18,000,000 will remain to fall due on 27 February 2014.
