(1) A maximum of 520,000,000 Conversion Shares (upon full conversion of possibly be issued Convertible Notes) may possibly be issued in relation to a memorandum of understanding signed on 31 January 2010 and agreements signed on 22 October 2010. Conversion Price of the possible issue of Shares is HK\$0.6.

(2) (a) On 18 July 2016, the Company entered into a Subscription Agreement with the Subscriber pursuant to which the Subscriber has conditionally agreed to subscribe for and the Company has conditionally agreed to allot and issue 3,700,000,000 Subscription Shares at the Subscription Price of HK\$0.16 per Subscription Share. The issue of Subscription Shares is subject to independent shareholders' approval at the extraordinary general meeting. For details, please refer to the Company's announcements dated 21 July 2016, 10 August 2016, 15 September 2016, 31 October 2016, 1 December 2016 and 16 December 2016; and

(b) Please refer to the Company announcement dated 3 March 2017, the Company announced that the Company is considering matters in relation to the lapse of the Subscription Agreement.

(3) (a) On 18 July 2016, the Company entered into a Placing Agreement with the Placing Agent pursuant to which the Placing Agent has conditionally agreed, on a fully underwritten basis, to procure not less than six Placées to subscribe for 800,000,000 Placing Shares at the Placing Price of HK\$0.16 per Placing Share. The issue of Placing Shares is subject to independent shareholders' approval at the extraordinary general meeting. For details, please refer to the Company's announcements dated 21 July 2016, 10 August 2016, 15 September 2016, 31 October 2016, 1 December 2016 and 16 December 2016; and

(b) Please refer to the Company announcement dated 3 March 2017, the Company announced that the Company is considering matters in relation to the lapse of the Placing Agreement.
