Remarks (if any):

The Company issued two tranches of the convertible notes both on 27 February 2009 in the aggregate amount of HK\$673,200,000 with an initial maturity date of 27 February 2014 which was extended to 27 February 2019. As at the date of this monthly return, the said convertible notes had a principal outstanding amount of HK\$533,700,000 which was held by COMPLANT International Sugar Industry Co., Ltd. (“Complant Sugar”) and convertible into a maximum of 889,500,000 conversion shares of the Company. On 27 February 2019, the Company and Complant Sugar entered into the second amendment deed to extend the term of the said convertible notes for a further term of five years from 27 February 2019 to 27 February 2024 (the “Amendment”) conditional to the approval by the shareholders of the Company. On 20 September 2019, the ordinary resolutions in relation to the Amendment was voted down by the independent shareholders of the Company and the said convertible notes became immediately due and payable.
