On 6 December 2016, the Company and one of its subsidiaries entered into two agreements with (i) Mr. Gu Changwei ("Mr. Gu") and (ii) separately, with Mr. Zhang Xiaoling (also known as Zhang Yibai, "Mr. Zhang"), pursuant to which the Company has conditionally agreed to allot and issue, respectively, 75,000,000 shares of the Company (the "Shares") to Mr. Gu (or his designated wholly-owned company) and 140,000,000 Shares to Mr. Zhang ((i) and (ii), together, the "New Shares").</p> <p>The New Shares were allotted and issued under the general mandate granted to the board of directors of the Company at the annual general meeting held on 1 June 2016. On 14 December 2016, the Company issued and allotted (i) 75,000,000 New Shares to Mr. Gu and (ii) 140,000,000 New Shares to Mr. Zhang.
