VOLUNTARY ANNOUNCEMENT BUSINESS UPDATE IN RELATION TO INVESTMENT IN FILM RIGHTS

This is a voluntary announcement made by the Company to provide Shareholders and potential investors an update on the latest business development in relation to several film rights invested by the Group, which were previously mentioned in the annual report of the Company for the year ended 31 December 2017.

FILM A

The Group invested RMB13.5 million in Film A for part of its income right. Film A is Us and Them ("後來的我們"), a romance film directed by Ms. Rene Liu (劉若英), produced by Mr. Zhang Yibai (張一白), and starred by Mr. Jing Boran (井柏然), Ms. Zhou Dongyu (周冬雨), Mr. Tian Zhuangzhuang (田壯壯) and Ms. Su Xiaoming (蘇小明).

Released in the PRC on 28 April 2018, Film A recorded the highest box office in the first week of May 2018 among other films and has already recorded a box office of over RMB1.2 billion as at the date of this announcement.

FILM B

The Group invested approximately RMB12.6 million in Film B for part of its income right. Film B is Ash Is Purest White ("江湖兒女"), a romance film directed by Mr. Jia Zhangke (賈樟柯), and starred by Mr. Liao Fan (廖凡), Ms. Zhao Tao (趙濤), Mr. Feng Xiaogang (馮小剛) and Mr. Xu Zheng (徐崢).

Film B is nominated as the only Chinese film among 17 other films for the official competition for the Palme d'Or of the 71st Festival de Cannes to be held in mid of May 2018, which is the highest prize awarded at the Festival de Cannes and is one of the most prestigious awards in the film industry.

FILM C

In March 2017, the Group invested RMB20 million in Film C for part of its Income Right. Film C is *Dying To Survive* ("我不是藥神"), a drama movie directed by Mr. Wen Muye (文牧野), co-produced by Mr. Ning Hao (寧浩) and Mr. Xu Zheng (徐崢), and starred by Mr. Xu Zheng, Mr. Zhou Yiwei (周一圍), Mr. Wang Chuanjun (王傳君) and Ms. Tan Zhuo (譚卓). The Vendor, an Independent Third Party, shall be fully responsible for the production of Film C. The Income Right has a term of 15 years from the first release date of Film C.

On 9 May 2018 (after trading hours), the Group was informed by the Vendor that Huoerguosi Dirty Monkey, Beijing Joy Leader and the Vendor entered into agreements, pursuant to which Huoerguosi Dirty Monkey and Beijing Joy Leader have agreed to acquire 15% and 15% of the Income Right respectively. As at the date of this announcement, to the best of the Directors' knowledge, information and belief, having made all reasonable enquiries, the ultimate controlling interest of Huoerguosi Dirty Monkey and Beijing Joy Leader are owned by Mr. Ning Hao and Mr. Xu Zheng respectively. The Board has no objection to the investments of Huoerguosi Dirty Monkey and Beijing Joy Leader in Film C, as the investments will not affect the interest of the Company and the Shareholders as a whole.

The Company is also in discussion with a potential purchaser, who is an Independent Third Party, for disposal of a small part of our Income Right at a premium. The Company will comply with the Listing Rules and make further announcement in this regard if necessary.

Given the encouraging results from the aforementioned films, the Group will focus more on investing in film projects.
