Rosh Ha'ayin, Israel, August 26, 2009 – Partner Communications Company Ltd. If the lawsuit is certified as a class action, the total amount of claim against Partner is estimated by the Plaintiffs to be approximately NIS 227,822,400.

Partner is reviewing and assessing the lawsuit and at this preliminary stage is unable to evaluate the probability of success of the lawsuit or the range of potential exposure, if any, with any degree of certainty.
