The Board announces that on 16 July 2010, the Audited Profit has been finalized as HK\$10,731,858 which is less than the Guaranteed Profit. Pursuant to the Agreement, the consideration of the Acquisition and the aggregate face value of the Non-voting Convertible Preference Shares shall be adjusted downward to HK\$85,854,864, which should be satisfied by the issuance of an aggregate of 214,637,160 Adjusted Non-voting Convertible Preference Shares by the Company to the Vendors. Pursuant to the terms of the Agreement, the Company has issued an aggregate of 214,637,160 Adjusted Non-voting Convertible Preference Shares to the Vendors on 16 July 2010.
