As at the date hereof, the three subscribers are (i) China Cinda (HK) Asset Management Co., Limited, which is an indirect wholly-owned subsidiary of China Cinda Asset Management Co., Ltd. (Stock code: 01359), subscribing for 640,000,000 Placing Shares; (ii) Chongqing Strategic Industry Co., Ltd. (重慶臨空戰略產業投資促進有限公司), subscribing for 320,000,000 Placing Shares; (iii) Chongqing Yufu (HongKong) Limited (重慶渝富(香港)有限公司), subscribing for 320,000,000 Placing Shares.
