Personal Data

Personal Information Collection Statement

The main provisions of the Personal Data (Privacy) Ordinance (the “**Privacy Ordinance**”) came into effect in Hong Kong on 20 December 1996. This personal information collection statement informs you of the policies and practice of the Offeror, ESL and the Registrar in relation to personal data and the Privacy Ordinance.

1. Reasons for the collection of your personal data

To accept the Offer for your Shares, you must provide the personal data requested. Failure to supply the requested data may result in the processing of your acceptance being rejected or delayed. It may also prevent or delay the despatch of the consideration to which you are entitled under the Offer.

2. Purposes

The personal data which you provide on this form may be used, held and/or stored (by whatever means) for the following purposes:

- processing your acceptance and verification of compliance with the terms and application procedures set out in this Form of Acceptance;
- conducting or assisting to conduct signature verification, and any other verification or exchange of information;
- distributing communications from the Offeror, ESL and/or their respective subsidiaries or agents and/or the Registrar;
- compiling statistical information and shareholder profiles;
- making disclosures as required by laws, rules or regulation (whether statutory or otherwise);
- disclosing relevant information to facilitate claims or entitlements;
- any other purpose in connection with the business of the Offeror, ESL and/or their respective holding companies, subsidiaries or agents and/or the Registrar; and

- the Offeror, ESL, their respective holding companies, subsidiaries and/or agent(s) and the Registrar;
- any agents, contractors or third party service providers who offer administrative, telecommunications, computer, payment or other services to the Registrar in connection with the operation of its business;
- any regulatory or governmental bodies;
- any other person or institutions with which you have or propose to have dealings, such as bankers, solicitors, accountants or stockbrokers; and
- any other persons whom the Offeror, ESL and/or the Registrar consider to be necessary or desirable in the circumstances.

個人資料收集聲明

個人資料(私隱)條例(「**私隱條例**」)的主要條文於一九九六年十二月二十日在香港生效。本個人資料收集聲明知會閣下有關收購人、英皇證券及過戶處就有關個人資料及私隱條例的政策及實務做法。

1. 收集閣下的個人資料的原因
