## **PROFIT WARNING**

This announcement is made by Li Bao Ge Group Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) pursuant to Rule 17.10 of the Rules Governing the Listing of Securities on the Growth Enterprise Market (the “**GEM Listing Rules**”) of The Stock Exchange of Hong Kong Limited (the “**Stock Exchange**”) and the Inside Information Provisions (as defined under the GEM Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong). Unless otherwise specified, terms used herein shall have the same meanings as those defined in the Company’s prospectus dated 24 June 2016.

The board (the “**Board**”) of directors (the “**Director(s)**”) of the Company wishes to inform the shareholders of the Company and potential investors that, based on a preliminary review of the unaudited management accounts of the Group for the six months ended 30 June 2016 (the “**Period**”) and assessment of the information currently available, the Group is expected to record a loss after tax for the Period as compared with a profit after tax recorded for the six months ended 30 June 2015. The loss-making position for the Period was mainly attributable to (i) the I-Square Restaurant, which was closed in November 2015 and contributed an operating profit of approximately HK\$7.0 million to the Group during the six months ended 30 June 2015, did not have profit contribution to the Group for the Period; (ii) the Sheung Wan Restaurant and the Beijing House Restaurant, which were opened at the end of October 2015, were yet to be profitable and incurred an operating loss during the Period; and (iii) the listing expenses of approximately HK\$7.6 million incurred by the Group during the Period in relation to the listing of the Company’s shares on the Growth Enterprise Market of the Stock Exchange.

As the Company is still in the process of finalising the unaudited consolidated results of the Group for the Period, the information contained in this announcement is only a preliminary assessment by the Board based on the latest information currently available, and is not based on any data or information which is finalized, audited or reviewed by the auditors of the Company. Shareholders and potential investors are advised to read carefully the announcement of the Company in relation to the results of the Group for the Period.

**Shareholders of the Company and potential investors should exercise caution when dealing in the securities of the Company.**
