**DISCLOSEABLE TRANSACTION  
DISPOSAL OF SHARES OF HAINING LEATHER MARKET**

The Board announces that, on 11 November 2016, Zhejiang Kasen disposed of an aggregate of 7,555,000 HLM Shares (representing approximately 0.67% equity interest in Haining Leather Market as at the date of this announcement based on public information available to the Company) through the block trade platform of the Shenzhen Stock Exchange to an individual investor at an aggregate consideration, after deduction of necessary transaction costs, of approximately RMB85,938,378 (equivalent to approximately HK\$97,857,411).

As the applicable percentage ratios as set out in the Listing Rules in respect of the Disposal is more than 5% but is less than 25%, the Disposal constitutes a discloseable transaction for the Company and is subject to the reporting and announcement requirements under Chapter 14 of the Listing Rules.

Reference is made to the announcement made by the Company on 3 October 2007 regarding the Acquisition and the announcement made by the Company on 27 January 2010 regarding the listing of the shares of Haining Leather Market on the Shenzhen Stock Exchange. Reference is also made to the announcement made by the Company on 28 August 2014 regarding the 2014 Disposal, and the announcements made by the Company on 14 May 2015 and 15 May 2015 regarding the 2015 Disposal.

**THE DISPOSAL**

The Board announces that, on 11 November 2016, Zhejiang Kasen disposed of an aggregate of 7,555,000 HLM Shares (representing approximately 0.67% equity interest in Haining Leather Market as at the date of this announcement based on public information available to the Company) through the block trade platform of the Shenzhen Stock Exchange to an individual investor at an aggregate consideration, after deduction of necessary transaction costs, of approximately RMB85,938,378 (equivalent to approximately HK\$97,857,411). The purchase price at which the Disposal was carried out is RMB11.39 (equivalent to approximately HK\$12.97) per HLM Share. Immediately prior to the completion of the Disposal, Zhejiang Kasen held 11,555,554 HLM Shares, representing approximately 1.03% of the total share capital of Haining Leather Market based

on public information available to the Company. Immediately after completion of the Disposal, Zhejiang Kasen held 4,000,554 HLM Shares, representing approximately 0.36% of the total share capital of Haining Leather Market based on public information available to the Company.

To the best of the knowledge, information and belief of the Directors, having made all reasonable enquiries, the individual investor of the Disposed Shares is an Independent Third Party.

### **Assets disposed of**

On 11 November 2016, Zhejiang Kasen disposed of an aggregate of 7,555,000 HLM Shares (representing approximately 0.67% equity interest in Haining Leather Market as at the date of this announcement based on public information available to the Company) through the block trade platform of the Shenzhen Stock Exchange to an individual investor. Immediately after completion of the Disposal, Zhejiang Kasen held 4,000,554 HLM Shares, representing approximately 0.36% of the total share capital of Haining Leather Market based on public information available to the Company.

### **Consideration**

The purchase price at which the Disposal was carried out is RMB11.39 (equivalent to approximately HK\$12.97) per HLM Share. The aggregate consideration, after deduction of necessary transaction costs, of the Disposal is approximately RMB85,938,378 (equivalent to approximately HK\$97,857,411) and are receivable in cash on settlement.

## **INFORMATION ABOUT HAINING LEATHER MARKET**

Haining Leather Market is indirectly non-wholly owned by 海寧市國有資產監督管理委員會 (State-owned Assets Supervision and Administrative Commission of Haining Municipal Government). Haining Leather Market is principally engaged in the development and operation of large leather product retail malls and was listed on the Shenzhen Stock Exchange on 26 January 2010.

According to the published financial statements of Haining Leather Market, the financial results of Haining Leather Market for the two years ended 31 December 2014 and 2015 are as follows:

The net asset value of Haining Leather Market as at 31 December 2015 was approximately RMB4,984,260,585 (equivalent to approximately HK\$5,675,541,545).

## **FINANCIAL EFFECTS OF THE DISPOSAL**

A gain on disposal in the amount of approximately RMB78,081,178 (equivalent to approximately HK\$88,910,474) in respect of the Disposal was arisen upon completion of the Disposal. The gain was calculated with reference to the difference between the acquisition cost of the HLM Shares at the time of the Acquisition and the disposal price, after deduction of necessary transaction costs, of the Disposed Shares. It is expected that the disposal gain will be applied as general working capital of the Group.

## **REASONS FOR AND BENEFITS OF THE DISPOSAL**

The Board believes that the Disposal is in the interests of the Shareholders and the Company as a whole as the Company was able to realise a portion of its investment in Haining Leather Market at a considerable profit as well as to further enhance and strengthen the financial position and cash flow of the Group.

The purchase price was determined after taking account of the recent closing prices of the HLM Shares and the block trade nature of the Disposal, the Directors (including the independent non-executive Directors) considered that the Disposal was made on normal commercial terms and that such terms were fair and reasonable so far as the Company and the Shareholders are concerned and that the Disposal was in the interests of the Company and the Shareholders as a whole.

## **LISTING RULES IMPLICATION**

As the applicable percentage ratios as set out in the Listing Rules in respect of the Disposal is more than 5% but is less than 25%, the Disposal constitutes a discloseable transaction for the Company and is subject to the reporting and announcement requirements under Chapter 14 of the Listing Rules.

## **GENERAL**

The Company is an investment holding company and its subsidiaries are principally engaged in the businesses of (a) manufacturing of automotive and furniture leather and upholstered furniture, (b) property development and (c) tourism resort-related business (comprising mainly tourism resort-related operation, operation of restaurant and hotel and provision of travel-related services) in the PRC.
