As at the date of the AGM, the Company had 1,160,152,985 Shares in issue (without taking into account the Shares repurchased by the Company prior to the date of the AGM but not yet cancelled as at the date of this announcement). Mr. Zhou Xiaosong and his associates which in aggregate controlled or were entitled to exercise control over the voting rights in respect of 8,173,912 Shares, representing approximately 0.7% of the total issued share capital of the Company as at the date of the AGM, have abstained from voting in respect of the ordinary resolution no. 2 proposed at the AGM. The total number of Shares held by the Shareholders entitled to attend and vote for or against all the ordinary resolutions (other than ordinary resolution no. 2) was 1,160,152,985 Shares. The total number of Shares held by the Independent Shareholders entitled to attend and vote for or against the ordinary resolution no. 2 was 1,151,979,073 Shares. There was no Shareholder who was entitled to attend the AGM but was only entitled to vote against the ordinary resolutions proposed at the AGM.
