DELAY IN DESPATCH OF CIRCULAR

As additional time is required to prepare the information to be included in the Circular, including, the financial information of the Group, the unaudited pro forma financial information of the remaining group and the valuation report on the Property, we, as instructed by and on behalf of the Company, apply to the Stock Exchange for a waiver from strict compliance with Rules 19.38 and Rules 19.48 of the GEM Listing Rules by extending the despatch date of the Circular to 5 May 2010.

The Circular containing, among other things, with further information in relation to the Disposal and the Proposed Special Dividend, together with the notice of SGM will be despatched to the Shareholders on 5 May 2010.

Reference is made to the announcement of the China Star Film Group Limited (the “**Company**”) dated 13 April 2010 (the “**Announcement**”) relating to, among other matters, the proposed disposal of the entire issue share of a wholly-owned subsidiary and its debts to an independent third parties and the distribution of cash dividend by the Company to the Shareholders on a pro rata basis.
