BAD WEATHER ARRANGEMENT FOR THE ANNUAL GENERAL MEETING TO BE HELD ON 15 AUGUST 2018

Reference is made to the circular (the “Circular”) and notice of the AGM (the “Notice”) of Luk Fook Holdings (International) Limited (the “Company”) both dated 16 July 2018. Unless otherwise stated, capitalised terms used herein shall bear the same meanings as defined in the Circular and the Notice.

BAD WEATHER ARRANGEMENT

According to the Notice of the Company, the AGM is scheduled to be convened at 11:30 a.m. on Wednesday, 15 August 2018 at 17/F., Luk Fook Jewellery Centre, No. 239 Temple Street, Jordan, Kowloon, Hong Kong.

Owing to the approach of typhoon, there is a risk that the weather condition in Hong Kong may deteriorate at the time originally scheduled for the AGM. In view of this, the Board would like to announce that in the event that in the morning on Wednesday, 15 August 2018 if Typhoon Signal No. 8 (or above) or a Black Rainstorm Warning Signal is hoisted:

- 1.) but lowered at or before 9:00 a.m., the AGM will be held as scheduled at 11:30 a.m. on the same day at the same venue; or
- 2.) but lowered after 9:00 a.m and before 2:00 p.m., the AGM will be adjourned to 5:00 p.m. on the same day at the same venue; or
- 3.) but lowered after 2:00 p.m., the AGM will be adjourned to 11:30 a.m. on Thursday, 16 August 2018 at the same venue.

If the AGM is so adjourned, all resolutions set out in the Circular and the Notice to be proposed at the AGM will remain unchanged, and all such resolutions will be proposed at the adjourned AGM.

All forms of proxy deposited with the Company’s share registrar and transfer office in Hong Kong, Computershare Hong Kong Investor Services Limited, for the purposes of the AGM will remain valid for the adjourned AGM.

If the AGM is so adjourned to Thursday, 16 August 2018, the Company will make a further announcement regarding the adjournment of annual general meeting, change of book closure date for ascertaining entitlement to final dividend and expected payment date in due course.
