In addition, CGL is the first laboratory in Hong Kong to obtain GB/T9288 accreditation in Gold Testing.

Set up in 1996, China Gems Laboratory Limited is operated by a group of experienced and certified gemologists. In 2005, CGL became one of the first accredited laboratories in Hong Kong that conformed to HKAS ISO/IEC 17025 in Jadeite Jade Testing. Subsequently in 2009, it obtained the accreditation in Diamond Testing and Grading, making it the first laboratory in Hong Kong to obtain both accreditations. In addition, CGL meets the ISO 9001:2008 Quality Management Systems Requirements, affirming its international level quality assurance system and professionally recognised product quality standard.
