A maximum of 246,000,000 Placing Shares under the Placing, which will be allotted and issued under the Issue Mandate, represent approximately 19.93% of the existing issued share capital of the Company of 1,234,349,830 Shares as at the date of this announcement and approximately 16.62% of the then issued share capital of 1,480,349,830 Shares as enlarged by the Placing Shares. The aggregate nominal value of the Placing Shares under the Placing will be HK\$24,600,000.

The Placing Price of HK\$0.18 represents (i) a discount of approximately 15.89% to the closing price of HK\$0.214 per Share as quoted on the Stock Exchange on the date of this announcement; and (ii) a discount of approximately 16.28% to the average closing price of HK\$0.215 per Share as quoted on the Stock Exchange in the last five consecutive trading days prior to the date of this announcement.

# **Ranking of Placing Shares**

The Placing Shares, when issued and fully paid, will rank pari passu in all respects among themselves and with the Shares in issue on the date of allotment and issue of the Placing Shares.

The Placing Price of HK\$0.18 represents (i) a discount of approximately 15.89% to the closing price of HK\$0.214 per Share as quoted on the Stock Exchange on the date of this announcement; and (ii) a discount of approximately 16.28% to the average closing price of HK\$0.215 per Share as quoted on the Stock Exchange in the last five consecutive trading days prior to the date of this announcement.

The Placing Price was determined with reference to the prevailing market price of the Share and was negotiated on an arm's length basis between the Company and the Placing Agent. The Directors consider that the terms of the Placing are fair and reasonable based on the current market conditions and in the interests of the Company and the Shareholders as a whole.

#### **Issue Mandate**
