UPDATE ON LITIGATION IN GUANGZHOU

Reference is made to the periodic announcements published by Mayer Holdings Limited (the "Company") monthly since 31 December 2015, among others, in relation to, on 17 December 2015, Guangzhou Administration for Industry and Commerce ("GAIC") has notified Guangzhou Mayer Corporation Ltd. ("Guangzhou Mayer") that its filings of the changes of unauthorized alterations of the Articles of Association of Guangzhou Mayer made on 30 May 2014 and 30 September 2014 respectively have been revoked (the "Revocation Notice"). On 19 April 2016, Guangdong Province Administration for Industry and Commerce ("GPAIC") upholds the Revocation Notice as a valid notice following a review.

Reference is further made to the periodic announcements published by the Company monthly since 29 December 2016, among others, in relation to, on 29 December 2016, Bamian Investments PTE Ltd., the wholly-owned subsidiary of the Company, being the third party, received an judgement (the "Judgement") that Guangzhou Railway Transportation Court First upholds the decisions of GPAIC and GAIC in respect of the Revocation Notice and dismisses Guangzhou Mayer's claim against GPAIC and GAIC under the action of administrative litigation number ((2016) \$\Bar{\Bar{\Bar{B}}}\$ 7101 行初 1283 號). On 9 January 2017, Guangzhou Mayer lodged an appeal (the "Appeal") with Guangzhou Railway Transportation Intermediate Court (the "GRTI Court") against the Judgement under an action number ((2017) \$\Bar{\Bar{B}}\$ 71 行終 239 號).

After the Appeal was heard by the GRTI Court on 6 April 2017, final judgment (the "**Final Judgement**") was handed down on 10 May 2017 dismissing the Appeal and upholding the Judgement. In the Final Judgment the Court has remarked, among others, that the ground of the Appeal could not be established. The judgment shall be the final judgment and shall have legal effect from the date of service.
