**VOLUNTARY ANNOUNCEMENT**

**Correction of Inaccurate Research**

We have noted the recent decrease in the price of shares in NagaCorp Limited (the “Company”) on what we consider to be a high volume of trading in the Company’s shares.

We confirm that there are no negotiations or agreements relating to intended acquisitions or realisations which are discloseable under Listing Rule 13.23, neither is the board aware of any matter discloseable under the general obligations imposed by Listing Rule 13.09 which is or may be of a price sensitive nature.

We have however noted what we consider to be a material inaccuracy in recent published research concerning the Company. In one, broadly quoted, research report it was stated that “The company is carrying US\$20m receivables, owed by junket operators on their books .... This is .... 41% of net assets making this a substantial risk on the company.” The Company wishes to clarify that the ratio of Total Receivables / Net Assets as at 31 December 2010, as reported in the Company’s 2010 Results Announcement (as announced on 14 February 2011), amounts to only 9%, computed as follows:

Current Trade and Other Receivables	USD24,936,000
Total Trade and Other Receivables	USD28,367,000
Net Assets	USD308,687,000
Ratio of Total Trade and Other Receivables to Net Assets	9%

The Company is of the opinion that the above computed ratio of 9% does not represent a substantial risk to the Company, as compared to the 41% incorrectly stated in the research report.
