The Company entered into a conditional share purchase agreement on 13/06/2011 (as amended by two supplemental agreements dated 28/12/2011 and 28/12/2015, respectively) (the “Share Purchase Agreement”) with Tan Sri Dr Chen Lip Keong (“Dr Chen”), the controlling shareholder of the Company, to acquire the entire equity interests in TanSriChen Inc. (“TSC Inc.”) and TanSriChen (Citywalk) Inc. (“City Walk Inc.”) both of which are incorporated in the British Virgin Islands and are beneficially owned by Dr Chen. The acquisition was approved by the shareholders of the Company at the extraordinary general meeting held on 30/01/2012. Completion of the acquisition is subject to completion of the construction of several projects, including the development and construction of the hotel and gaming complex and a retail walkway adjacent to NagaWorld in Phnom Penh, Cambodia, to be undertaken by TSC Inc. and City Walk Inc.</p> <p>The agreed consideration for the transaction is US\$369,000,000, divided as to US\$275,000,000 for TSC Inc. (“TSCLK Complex Project”) and US\$94,000,000 for City Walk Inc. (“NagaCity Walk Project”). The consideration will be settled, at the election of Dr Chen, in the form of consideration shares (being new ordinary shares of the Company), to be allotted and issued at a price of HK\$1.8376 per consideration share; or in the form of convertible bonds issued by the Company and convertible at the option of the bondholder into conversion shares (being new ordinary shares in the Company), also to be allotted and issued at a conversion price of HK\$1.8376 per conversion share; or through a combination of consideration shares and convertible bonds, to an aggregate value of US\$369,000,000.</p> <p>According to the Share Purchase Agreement, Dr Chen may elect either Split Completion (meaning the completion of the NagaCity Walk Project would take place in advance of completion of the TSCLK Complex Project) or Combined Completion (meaning the two projects would be completed at the same time).</p> <p>The shares and/or convertible bonds themselves will not be issued until completion of the acquisition pursuant to the Share Purchase Agreement.</p> <p>At the election of Dr Chen on 17/05/2016, (i) completion of the NagaCity Walk Project should take place in advance of completion of the TSCLK Complex Project and (ii) such consideration should be settled by way of the issue of convertible bonds (the “NagaCity Walk Convertible Bonds”) in accordance with the terms of the Share Purchase Agreement. Accordingly, the Company on 17/05/2016 issued to Dr Chen the NagaCity Walk Convertible Bonds in the principal amount of US\$94,000,000 on a perpetual basis with no maturity date. Given that the consideration for the NagaCity Walk Project is US\$94,000,000, conversion in full of the NagaCity Walk Convertible Bonds would result</p>		

in 439,072,360* conversion shares being issued. The conversion price and the number of the conversion shares have been adjusted from HK\$1.6699 per share to HK\$1.530 per share and from 439,072,360 conversion shares to 479,175,614 conversion shares, respectively, as a result of the placing of existing shares (completion of which took place on 5 September 2016) and the top-up subscription of new shares under the Company's general mandate (completion of which took place on 9 September 2016), and are subject to further adjustment in the event of any future capital restructuring, if any.

The total number of new ordinary shares of the Company that stands to be allotted and issued as consideration shares or on exercise of the convertible bonds to be issued for the TSCLK Complex Project (the "TSCLK Complex Convertible Bonds") is 1,167,283,413*.

Accordingly, the total number of new ordinary shares of the Company that stands to be allotted and issued as consideration shares or on exercise of the NagaCity Walk Convertible Bonds and the TSCLK Complex Convertible Bonds is 1,646,459,027*#.
