1. On 9 October 2012, Options to subscribe for a total of 570,000,000 Shares (adjusted to 114,000,000 Shares after Share Consolidation effective on 20 November 2012) were granted under the Share Option Scheme with the following exercise period:-

(i) 60% of the Options is exercisable upon the date of grant but before the expiry of 10 calendar years from the date of the offer letter to each of the Grantees (the "Date of the Offer Letter");

(ii) 20% of the Options is exercisable as at 1 April 2013 but before the expiry of 10 calendar years from the Date of the Offer Letter; and

(iii) The remaining 20% of the Options is exercisable as at 1 October 2013 but before the expiry of 10 calendar years from the Date of the Offer Letter.

2. On 2 August 2013, the Company issued the Tranche A Convertible Notes in the aggregate principal amount of HK\$870,000,000 and the Tranche B Convertible Notes in the aggregate principal amount of HK\$300,000,000 to Bidfast Investment Limited, Kingspot Investment Limited, Grandest International Limited, Alliance Elegant Limited and Broadlink Enterprises Limited as part of the consideration to acquire all the issued shares of Sinbo Investment Limited.
