- To be valid, this form of proxy, together with the power of attorney (if any) or other authority (if any) under which it is 7. signed, or a notarially certified copy thereof, must be lodged at the Company's branch share registrar, Hong Kong Registrars Limited at Rooms 1806-1807, 18th Floor, Hopewell Centre, 183 Queen's Road East, Wanchai, Hong Kong, not less than 48 hours before the time appointed for holding the meeting or adjourned meeting.
- Completion and delivery of the form of proxy will not preclude a member from attending and voting in person at the 8. meeting if the member so desires and in such event, the instrument appointing a proxy shall be deemed to be revoked.
