### **Annual General Meeting held on 29 May 2015 – Poll Results**

At the Annual General Meeting of Playmates Holdings Limited (the “**Company**”) held on 29 May 2015 (“**AGM**”), a poll was demanded by the Chairman of the Company for voting on all proposed resolutions as set out in the notice of AGM dated 13 April 2015.

As at the date of the AGM, the number of issued shares of the Company was 227,378,000 shares, which was the total number of shares entitling the holders to attend and vote for or against all resolutions at the AGM.
