Annual General Meeting held on 27 May 2016 – Poll Results

At the Annual General Meeting of Playmates Toys Limited (the “**Company**”) held on 27 May 2016 (“**AGM**”), a poll was demanded by the Chairman of the Company for voting on all proposed resolutions as set out in the notice of AGM dated 14 April 2016.

As at the date of the AGM, the number of issued shares of the Company was 1,212,805,000 shares, which was the total number of shares entitling the holders to attend and vote for or against all resolutions at the AGM.
