INTRODUCTION

The purpose of this circular is:

- (a) to provide details regarding re-election of the retiring Directors;
- (b) to provide details regarding grant of the General Mandates;
- (c) to provide you with details regarding the refreshing of the 10% limit on grant of options under the Share Option Scheme; and
- (d) notice of the Annual General Meeting.

LETTER FROM THE BOARD

RE-ELECTION OF RETIRING DIRECTORS

Pursuant to bye-law 98(A) of the Bye-laws, Mr. Chan Kwok Chuen, Augustine, Mr. Chan Fut Yan and Mr. Lee Kit Wah shall retire from office by rotation at the Annual General Meeting. Brief biographical and other details of the retiring Directors offering themselves for re-election, which are required to be disclosed under the Listing Rules, are set out in the Appendix I to this circular.

Mr. Lee Kit Wah, being an independent non-executive Director eligible for re-election at the Annual General Meeting, has provided his annual confirmation of independence pursuant to Rule 3.13 of the Listing Rules. The Company is of the view that Mr. Lee Kit Wah meets the independence guidelines set out in Rule 3.13 of the Listing Rules and is independent in accordance with the terms of the guidelines.

GENERAL MANDATES TO ISSUE SHARES AND TO REPURCHASE SHARES

At the annual general meeting of the Company held on 29th September, 2009, general mandates were granted to the Directors authorising them, inter alia, (a) to exercise the powers of the Company to allot and issue Shares not exceeding 20% of the Share Capital as at 29th September, 2009; (b) to repurchase Shares not exceeding 10% of the Share Capital as at 29th September, 2009; and (c) to extend the general mandate to issue Shares by the number of Shares purchased under the repurchase mandate mentioned in (b) above. Such general mandates will expire at the conclusion of the Annual General Meeting. Ordinary resolutions will be proposed at the Annual General Meeting to authorise the Directors, inter alia, (i) to exercise the powers of the Company to allot and issue Shares not exceeding 20% of the Share Capital as at the date of the passing of such resolution; (ii) to repurchase Shares not exceeding 10% of the Share Capital as at the date of the passing of such resolution; and (iii) to extend the general mandate to issue the Shares by the number of Shares purchased under the Repurchase Mandate.

As at the Latest Practicable Date, there were 753,695,343 Shares in issue. Subject to the passing of the ordinary resolutions to approve the General Mandates at the Annual General Meeting and on the basis that no further Shares are issued or repurchased between the Latest Practicable Date and the date of the Annual General Meeting, the Company would be allowed to issue up to a maximum of 150,739,068 Shares under the Issue Mandate and to repurchase up to a maximum of 75,369,534 Shares under the Repurchase Mandate.

The Directors believe that it is in the interests of the Company and the Shareholders as a whole if the General Mandates are granted at the Annual General Meeting. The Issue Mandate provides the Directors with flexibility to issue Shares especially in the context of a fund raising exercise in a timely manner or a transaction involving an acquisition by the Group where Shares are to be issued as consideration and which has to be completed speedily. However, as at the Latest Practicable Date, the Directors, in the event the Issue Mandate is approved by the Shareholders, have no present intention of any acquisition by the Company nor any present plan for raising capital by issuing new Shares under the proposed Issue Mandate.

The Company at present does not have any plan for repurchases of Shares. Repurchases will only be made when the Directors believe that such a repurchase will benefit the Company and the Shareholders as a whole. Considering the rapid changes in the market conditions, the Repurchase Mandate can provide more flexibility to the Directors to enhance the net asset value of the Company and/or its earnings per Share.

An explanatory statement providing all the information required under the Listing Rules concerning the Repurchase Mandate is set out in the Appendix II to this circular.

REFRESHING OF THE 10% LIMIT ON GRANT OF OPTIONS UNDER THE SHARE OPTION SCHEME

By ordinary resolution passed at the special general meeting of the Shareholders held on 16th January, 2002, the Company adopted the Share Option Scheme (which was amended on 19th September, 2007).

The Company may refresh the Scheme Mandate Limit by an ordinary resolution of the Shareholders at general meeting provided that the Scheme Mandate Limit so refreshed shall not exceed 10% of the total number of issued Shares as at the date of the Shareholders' approval of the refreshing of the Scheme Mandate Limit. Options previously granted under any existing schemes (including options outstanding, cancelled, or lapsed in accordance with the relevant scheme rules or exercised options) shall not be counted for the purpose of calculating the limit as refreshed.

As at 16th January, 2002 (being the date of adoption of the Share Option Scheme), the total number of issued shares of the Company was 630,960,774, thus the Scheme Mandate Limit was 63,096,077 shares of the Company. By ordinary resolution passed on 29th September, 2009, the Scheme Mandate Limit was refreshed to 75,368,953 Shares (representing approximately 10% of the Shares in issue as at 29th September, 2009). No share options of the Company were granted during the period from 29th September, 2009 to the Latest Practicable Date.

As at the Latest Practicable Date, there were 753,695,343 Shares in issue and options outstanding under the Share Option Scheme whereby a total of 28,914,000 Shares, representing approximately 3.84% of the existing Share Capital, may be issued at an exercise price of HK\$2.52 per Share (subject to adjustments).

Assuming no further issue or repurchase of Shares prior to the Annual General Meeting, upon the refreshing of the Scheme Mandate Limit by the Shareholders at the Annual General Meeting, the Company may grant options entitling holders thereof to subscribe for a total of 75,369,534 Shares (representing approximately 10% of the Shares in issue as at the date of the Annual General Meeting approving the refreshing of the Scheme Mandate Limit).

To the extent that there are any unutilized options under the Scheme Mandate Limit as refreshed by the Shareholders on 29th September, 2009 which amounted to options, if granted, entitling holders thereof to subscribe for a total of 75,368,953 Shares as at the Latest Practicable Date, all such unutilized options will be considered as lapsed upon the approval of the refreshment of the Scheme Mandate Limit at the Annual General Meeting and the Company will not be allowed to grant any further options pursuant to the unutilized options. No options may be granted if this will result in the number of Shares which may be issued upon exercise of all outstanding options granted and yet to be exercised under the Share Option Scheme and any other share option scheme(s) of the Company exceed 30% of the total number of Shares in issue from time to time.

With the increase in Share Capital, the refreshed Scheme Mandate Limit allows the Company to grant options over a larger number of Shares (ie. 75,369,534 Shares) than the existing Scheme Mandate Limit (ie. 75,368,953 Shares). The Company believes the refreshment of the Scheme Mandate Limit would allow the Company to achieve the purpose of the Share Option Scheme which is to provide incentive or reward to the Eligible Persons for their contribution to, and continuing efforts to promote the interests of, the Company. The Directors consider that the refreshing of the Scheme Mandate Limit is in the interests of the Company and the Shareholders as a whole as it provides the Company with more flexibility in providing incentives to those Eligible Persons by way of granting of options.

The refreshing of the Scheme Mandate Limit is conditional on:

- (a) the passing of an ordinary resolution to approve the refreshing of the Scheme Mandate Limit by the Shareholders at the Annual General Meeting; and
- (b) the Listing Committee of the Stock Exchange granting listing of and permission to deal in the Shares (representing 10% of the Shares in issue as at the date of the Annual General Meeting approving the refreshing of the Scheme Mandate Limit) which may fall to be issued pursuant to the exercise of options under the Share Option Scheme and any other share option scheme(s) of the Company.

Application will be made to the Listing Committee of the Stock Exchange for the approval of the listing of and permission to deal in the Shares (representing a maximum of 10% of the total number of Shares in issue as at the date of the Annual General Meeting approving the refreshing of the Scheme Mandate Limit) which may fall to be issued pursuant to the exercise of options under the Share Option Scheme and any other share option scheme(s) of the Company.

ANNUAL GENERAL MEETING

A notice convening the Annual General Meeting is set out on pages 11 to 14 of this circular at which resolutions will be proposed, inter alia, to approve the re-election of retiring Directors, the grant of the General Mandates, the extension of the Issue Mandate by the number of Shares purchased under the Repurchase Mandate and the refreshing of the Scheme Mandate Limit.

Pursuant to the Listing Rules, any vote of shareholders at a general meeting must be taken by poll. The Chairman of the Annual General Meeting will therefore put each of the resolutions to be proposed at the Annual General Meeting to be voted by way of a poll pursuant to bye-law 79 of the Bye-laws.

A form of proxy for use by the Shareholders at the Annual General Meeting is enclosed. If you do not intend to attend the meeting, you are requested to complete the form of proxy in accordance with the instructions printed thereon and return it to the principal place of business of the Company in Hong Kong at 30th Floor, Bank of America Tower, 12 Harcourt Road, Central, Hong Kong as soon as possible and in any event not less than 48 hours before the time appointed for holding of the Annual General Meeting or any adjournment thereof (as the case may be). Delivery of the form of proxy will not preclude you from attending and voting in person at the meeting or any adjournment thereof should you so wish.

None of the Shareholders is required to abstain from voting at the Annual General Meeting pursuant to the Listing Rules.

RECOMMENDATION

The Directors consider that the re-election of Directors, the grant of the General Mandates, the extension of the Issue Mandate by the number of Shares purchased under the Repurchase Mandate and the refreshing of the Scheme Mandate Limit are in the interests of the Company and the Shareholders as a whole and recommend the Shareholders to vote in favour of all resolutions to be proposed at the Annual General Meeting.

The biographical and other details of the Directors standing for re-election at the Annual General Meeting are set out below:

Chan Kwok Chuen, Augustine, aged 51, joined the Company as an executive Director in November 1997 and is also a director of various subsidiaries of the Group. Mr. Chan holds a diploma in arts and has over 27 years' experience in trading business in the PRC. Mr. Chan is the managing director of Hanny Holdings Limited ("Hanny") (275.HK). Mr. Chan is the younger brother of Dr. Chan Kwok Keung, Charles, the Chairman of the Company and the sole director and beneficial owner of Chinaview International Limited and Galaxyway Investments Limited which are substantial shareholders of the Company, and is the uncle of Mr. Chan Yiu Lun, Alan, an executive director of the Company. Save as disclosed herein, Mr. Chan did not hold any other directorship in public listed companies in the last three years preceding the Latest Practicable Date.

As at the Latest Practicable Date, Mr. Chan held options with rights to subscribe for 1,830,000 Shares, representing approximately 0.24% of the existing Share Capital, at an exercise price of HK\$2.52 per Share (subject to adjustments) exercisable during the period from 28th March, 2008 to 27th March, 2011. Save as aforesaid, Mr. Chan did not have any interest in Shares or underlying shares of the Company pursuant to Part XV of the SFO nor did he have any relationship with any director or senior management or substantial shareholder or controlling shareholder of the Company.

Mr. Chan has entered into a service contract with the Group that could be terminated by giving the other party three months' advance notice. Mr. Chan is subject to retirement by rotation and re-election at least once every three years at the annual general meeting and in accordance with the Bye-laws. He will receive a director's fee, currently being HK\$10,000 per annum, determined by the Board or its delegated committee pursuant to the authority given by the Shareholders at the Company's general meetings, other emoluments (including salary and housing benefit), currently being HK\$161,000 per month, and a discretionary bonus which is based on the performance of the Group and of Mr. Chan, determined by the Board or its delegated committee with reference to the prevailing market conditions.

On 15th November, 2005, the Securities and Futures Commission (the "SFC") criticized the then Board for breaching Rule 21.3 of the Takeovers Code in respect of the dealing in the securities of Hanny by the Company during an offer period without the consent of Executive Director of the Corporate Finance Division of the SFC.

Save as disclosed herein, in connection with the re-election of Mr. Chan as a Director, there are no matters that need to be brought to the attention of the Shareholders nor is there any information to be disclosed by the Company pursuant to any of the requirements under the provisions of Rule 13.51(2) of the Listing Rules.

Chan Fut Yan, aged 56, joined the Company as an executive Director in December 1997 and is also a director of various subsidiaries of the Group. Mr. Chan has over 37 years' experience in the local construction field specialising in planning of construction business. He is also the managing director of ITC Properties Group Limited (199.HK) and the deputy chairman and an executive director of Paul Y. Engineering Group Limited (577.HK). Save as disclosed herein, Mr. Chan did not hold any other directorship in public listed companies in the last three years preceding the Latest Practicable Date.

As at the Latest Practicable Date, Mr. Chan held options with rights to subscribe for 3,812,500 Shares, representing approximately 0.51% of the existing Share Capital, at an exercise price of HK\$2.52 per Share (subject to adjustments) exercisable during the period from 28th March, 2008 to 27th March, 2011. Save as aforesaid, Mr. Chan did not have any interest in Shares or underlying shares of the Company pursuant to Part XV of the Securities and Futures Ordinance nor did he have any relationship with any director or senior management or substantial shareholder or controlling shareholder of the Company.

Mr. Chan has entered into a service contract with the Group that could be terminated by giving the other party three months' advance notice. Mr. Chan is subject to retirement by rotation and re-election at least once every three years at the annual general meeting and in accordance with the Bye-laws. He will receive a director's fee, currently being HK\$10,000 per annum, determined by the Board or its delegated committee pursuant to the authority given by the Shareholders at the Company's general meetings, a salary, currently being HK\$50,000 per month which is based on Mr. Chan's duties and responsibilities.

Save as disclosed herein, in connection with the re-election of Mr. Chan as a Director, there are no matters that need to be brought to the attention of the Shareholders nor is there any information to be disclosed by the Company pursuant to any of the requirements under the provisions of Rule 13.51(2) of the Listing Rules.

Lee Kit Wah, aged 54, joined the Company as an independent non-executive Director in July 2004. He is also the Chairman of the Audit Committee and a member of the Remuneration Committee of the Company. Mr. Lee graduated from University of Toronto with a Bachelor's Degree in Commerce. He is a fellow member of the Hong Kong Institute of Certified Public Accountants, the Association of Chartered Certified Accountants and the Taxation Institute of Hong Kong. He is a member of the Institute of Chartered Accountants in England and Wales. He has been practising as a certified public accountant in Hong Kong since 1988 and is the managing director of an accounting firm. Mr. Lee is also an independent non-executive director of Sinocom Software Group Limited (299.HK). Save as disclosed herein, Mr. Lee did not hold any other directorship in public listed companies in the last three years preceding the Latest Practicable Date.

As at the Latest Practicable Date, Mr. Lee held options with rights to subscribe for 381,250 Shares, representing approximately 0.05% of the existing Share Capital, at an exercise price of HK\$2.52 per Share (subject to adjustments) exercisable during the period from 28th March, 2008 to 27th March, 2011. Save as aforesaid, Mr. Lee did not have any interest in Shares or underlying shares of the Company pursuant to Part XV of the SFO nor did he have any relationship with any director or senior management or substantial shareholder or controlling shareholder of the Company.

Mr. Lee has not entered into any service contract with the Company and therefore the length of service of Mr. Lee with the Company is subject to retirement by rotation and re-election at least once every three years at the annual general meeting and in accordance with the Bye-laws. There is no agreement between the Company and Mr. Lee in respect of prior notice given by either party for termination of service with regard to his engagement as independent non-executive Director. Mr. Lee will receive director's fee, currently being HK\$200,000 per annum, determined by the Board as authorised by the Shareholders at general meetings of the Company with reference to prevailing market conditions.

Save as disclosed herein, in connection with the re-election of Mr. Lee as a Director, there are no matters that need to be brought to the attention of the Shareholders nor is there any information to be disclosed by the Company pursuant to any of the requirements under the provisions of Rule 13.51(2) of the Listing Rules.

This is an explanatory statement given to the Shareholders relating to the proposed ordinary resolution authorising the Directors to repurchase Shares to be passed by the Shareholders at the Annual General Meeting.

This explanatory statement contains a summary of the information required pursuant to Rule 10.06 of the Listing Rules which is set out as follows:

Share capital

- As at the Latest Practicable Date, the authorised share capital comprised 102,800,000,000 Shares, of which a total of 753,695,343 Shares were issued and fully paid.
- Assuming that no further Shares are issued or repurchased after the Latest Practicable Date and before the date of the Annual General Meeting, there will be 753,695,343 Shares in issue, and exercise in full of the Repurchase Mandate would result in up to a maximum of 75,369,534 Shares being repurchased by the Company during the relevant period referred to in the ordinary resolution numbered 5(B) of the notice of the Annual General Meeting.

Reasons for repurchases

- The Directors believe that it is in the best interests of the Company and the Shareholders as a whole for the Directors to have a general authority from the Shareholders to enable the Directors to purchase the Shares on the market. Such repurchases may, depending on market conditions and funding arrangements at the time, lead to an enhancement of the net asset value of the Company and/or its earnings per Share and will benefit the Company and the Shareholders as a whole.

Funding of repurchases

- The repurchase of Shares shall be made with funds legally available for such purpose in accordance with the Company's memorandum of association and the Bye-laws and the applicable laws of Bermuda. Under Bermuda law, repurchases may only be effected out of the capital paid up on the purchased Shares or out of funds of the Company otherwise available for dividend or distribution or out of the proceeds of a fresh issue of shares made for the purpose. Any premium payable on a purchase over the par value of the Shares to be purchased must be provided for out of funds of the Company otherwise available for dividend or distribution or out of the Company's share premium account before the Shares are repurchased. It is envisaged that the funds required for any repurchase would be derived from such sources.
- As compared to the financial position of the Company as at 31st March, 2010 (being the date of the Company's latest audited accounts), the Directors consider that the repurchases of securities will have no material adverse impact on the working capital and the gearing position of the Company in the event that the Repurchase Mandate were to be exercised in full at any time during the proposed repurchase period. The Directors do not propose to exercise the Repurchase Mandate to such an extent as would, in the circumstances, have a material adverse effect on the working capital requirements of the Company or the gearing levels which, in the opinion of the Directors, are from time to time appropriate for the Company.

Directors, their associates and connected persons

- None of the Directors or, to the best of their knowledge having made all reasonable enquiries, any of their associates, as defined in the Listing Rules, has any present intention, in the event that the Repurchase Mandate is approved by the Shareholders, to sell Shares to the Company.
- No connected person, as defined in the Listing Rules, has notified the Company that he has a present intention to sell Shares to the Company, or has undertaken not to do so, in the event that the Repurchase Mandate is approved by the Shareholders.

Undertaking of the Directors

- The Directors have undertaken to the Stock Exchange that, so far as the same may be applicable, they will exercise the Repurchase Mandate in accordance with the Listing Rules, the Bye-laws and the applicable laws of Bermuda.

Share repurchase made by the Company

- The Company had not purchased any Shares, whether on the Stock Exchange or otherwise, in the six months preceding the Latest Practicable Date.

GENERAL

If as a result of a repurchase of Shares, a Shareholder's proportionate interest in the voting rights of the Company increases, such increase will be treated as an acquisition of voting rights for the purpose of the Takeovers Code. As a result, a Shareholder or a group of Shareholders acting in concert, depending on the level of increase in Shareholders' interest, could obtain or consolidate control of the Company and become obliged to make a mandatory offer in accordance with Rule 26 of the Takeovers Code. If the Company were to repurchase Shares up to the permitted maximum of 10% of the Share Capital, such parties may together with any other parties acting in concert with them become obliged to make a mandatory offer in accordance with Rule 26 of the Takeovers Code.

As at the Latest Practicable Date, Galaxyway, which is ultimately and beneficially owned by Dr. Chan Kwok Keung, Charles ("Dr. Chan"), held 202,678,125 Shares, representing approximately 26.89% interest in the Share Capital. Dr. Chan also personally held 61,016,330 Shares, representing approximately 8.09% of the Share Capital. On the basis that no further Shares are issued or repurchased and that there is no change in shareholding in the Company owned by Galaxyway and Dr. Chan and in the event that the Repurchase Mandate is exercised in full, the shareholding of Galaxyway and Dr. Chan would, in aggregate, be increased to approximately 38.87% of the Share Capital. Should such increase arise, Galaxyway and Dr. Chan would become obliged to make a mandatory offer for all Shares not already owned by them or their concert parties under Rule 26 of the Takeovers Code. The Directors have no present intention to exercise the Repurchase Mandate to an extent which will result in the number of Shares held by the public being reduced to less than 25%.
