The board (the “**Board**”) of directors (the “**Director(s)**”) of Sino-Tech International Holdings Limited (the “**Company**”) is pleased to announce that at the annual general meeting of the Company held on 6 June 2016 (the “**AGM**”), all the proposed resolutions as set out in the notice of the AGM dated 21 April 2016 (the “**AGM Notice**”) were duly passed by the shareholders of the Company (the “**Shareholders**”) by way of poll.

As at the date of the AGM, the total number of issued ordinary shares of the Company was 13,889,198,580 shares, the holders of which were entitled to attend and vote for or against the resolutions of the AGM.
