## SUMMARY OF POWER GENERATION FOR FEBRUARY 2024

This voluntary announcement is made by Shandong Hi-Speed New Energy Group Limited (the "Company", together with its subsidiaries, the "Group") to keep the shareholders and potential investors of the Company informed of the latest business development of the Group.

The board (the "Board") of directors (the "Directors") of the Company announces that, according to the Company's preliminary statistics currently available, the power generation of the Group on a consolidated basis amounted to approximately 409,004 megawatt-hour ("MWh") for February 2024, representing an increase of approximately 4.8% compared with the corresponding period of 2023. For the two months ended 29 February 2024 (the "Period"), the aggregate power generation of the Group amounted to approximately 889,764 MWh, representing an increase of approximately 10.6% compared with the corresponding period of 2023.

The operating power generation\* of the projects held and/or managed by the Group, the associates and the joint ventures of the Group for February 2024 was approximately 414,505 MWh, representing a decrease of approximately 6.9% compared with the corresponding period of 2023. For the Period, the aggregate operating power generation of the projects held and/or managed by the Group, the associates and the joint ventures of the Group amounted to approximately 901,086 MWh, representing a decrease of approximately 1.1% compared with the corresponding period of 2023.
