The proxy needs not be a member of the Company, but must attend the AGM (or any adjournment thereof) to represent you.

- 3. This proxy form must be signed and dated by the member of the Company or his/her attorney duly authorised in writing. In the case of joint holders, any one of such joint holders any sign this proxy form.
