1. The shipment volume of handset lens sets decreased by 11.0% YoY, which was mainly due to the high base of shipment volume in the same period of last year and the current weak demand from the overall smartphone market.
2. The shipment volume of vehicle lens sets increased by 55.3% MoM, which was mainly due to the low base of shipment volume in December brought by the Christmas Holiday.
3. The shipment volume of handset camera modules decreased by 23.3% YoY, which was mainly due to the high base of shipment volume in the same period of last year and the current weak demand from the overall smartphone market.
